## Stettler Steel Wheel Stampede Parade

### Rules and Regulations

In order to ensure a safe and rewarding parade day for both the participants and the audience, we will enforce the following rules and regulations. Please read the following documentation carefully and ensure that all members associated with your entry are familiar with these rules and regulations.

The parade route is 4.0 km in length and will take approximately 1 -1.5 hours to complete. All participants are to ensure their entries are able to maintain a steady and consistent speed on the route as to not interfere with the constant motion of the parade and afford no gaps for spectators. Entries must not deviate from the established parade route unless directed by a parade official or R.C.M.P. officer.

The Stettler Steel Wheel Stampede Parade will run rain or shine.

1. All participants enter the Stampede Parade at their own risk. The Town of Stettler, Stettler Regional Board of Trade and Community Development, staff, and volunteers assume no liability.
2. **All parade entries including livestock must provide a copy of their own liability insurance with parade application.** Insurance must include the Stettler Regional Board of Trade and Community Development and the Town of Stettler as additional insureds. A minimum \$1,000,000 public liability is required. If a tow vehicle is owned by a different entity other than the applicant, the additional insurance policy must be provided by the owner of the tow vehicle.
3. The Stettler Board of Trade reserves the right to refuse access to the Parade by any entry deemed unsuitable or dangerous, interferes with the progress of the parade, or any other reason deemed appropriate.
4. All entries must be at the marshalling area (Stettler Curling Club 5111 – 46 Avenue)- **Access from 44<sup>th</sup> / 45<sup>th</sup> Avenue ONLY**) any time between 2:00 pm and 2:45 pm. Please arrange to have your float decorated before arriving at the marshalling area. Parade position will be assigned by members of the Parade Committee.
5. For Safety reasons **candy or advertising items may only be handed out** along the parade route. **Under no circumstances will throwing of items be allowed.** To ensure the comfort and safety of all spectators viewing the parade, water guns or apparatus that shoots water or other material are strictly prohibited.

6. All drivers must have a valid driver's license and may be asked to present their license when they arrive to the marshalling area. All entries must allow the driver a 180-degree view of the route at all times. All entries, detached or otherwise, should have direct communication with the driver. Drivers of motorized vehicles must be at least 16 years of age. NO EXCEPTIONS.
7. Protective equipment, especially helmets, **must be worn** for motorcycling, rollerblading, biking and skateboarding no matter the age. Helmets must be worn by youth under the age of 16 for livestock participants.
8. All units carrying people must be equipped with adequate restraining devices that can reasonably be considered capable of stopping someone from falling from the unit.
9. Adequate supervision of children and youth must be provided, prior to and during the parade. Suggested 1 adult to 8 children.
10. All animals must be treated humanely and are to be fed and watered before and after the parade. Entrants are responsible for ensuring the assembly area is clean upon departure.
11. All decorative materials must be fire retardant and no flammable materials may be carried on the float, in vehicles or on people. It is strongly suggested that all entries be equipped with a fire extinguisher kept within reach of the driver/operator.
12. In the case of emergency, parade participants must move to the right of the parade route in order to allow clear, unhindered access for Emergency vehicles.
13. **No smoking, prohibited drugs, cannabis or alcoholic beverages are allowed in the assembly area or on parade entries. No amount of alcohol, cannabis and/or prohibited drugs may be consumed prior to entering the assembly location.** Participants whom parade officials believe have consumed alcohol, cannabis or prohibited drugs prior to or during the parade will be removed from the parade and dealt with by local authorities as required.
